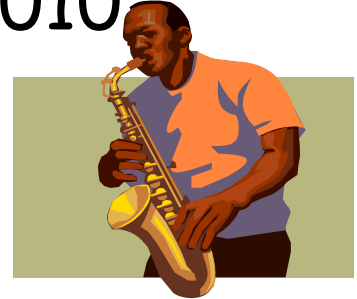

PAYMENT PROCEDURE & SCHEDULE:

DEPOSIT: \$100 per person NON-REFUNDABLE deposit at time of booking.

BALANCE: Final payment by JUNE 15, 2010 or space will be cancelled.

CHARGE CARD PAYMENTS: VISA or MASTERCARD may be used prior to JUNE 15, 2010. However, you must come into the office to sign the charge slip or fax it. Checks and Money Orders also accepted until JUNE 15^h.

AFTER JUNE 15, 2010: All bookings/payments made after June 15th, must be PAID IN FULL, **IN CASH**.

SEATING: Seating will be assigned on a first come basis by date of deposit in our office. However, seat locations will be re-assigned if final payment is late.

CANCELLATION POLICY: \$100 per person cancellation fee from date of booking, through JUNE 15, 2010. NO REFUNDS JUNE 16, 2010 or later.

NAME CHANGES: \$10 per person fee after JUNE 15, 2010. No name changes will be accepted after JUNE 25, 2010.

CONCERT TICKETS: The Friday and Saturday tickets included in your package are **LOWER STADIUM SEATS**. Upgrades available to two types of VIP seating: **VIP TURF** (folding chairs on the field in front of the stages) OR **VIP CLUB LEVEL** (these are higher than the Stadium seats above, but give you access to the VIP Club Level Lounge on each side of the stadium – an air-conditioned area with TV's, bars, concession stands for food & drink, tables/stools and concert screens - holds 2000 people). Please advise your preference at the time of booking. However, no particular seats can be guaranteed.

UPGRADING TO VIP TURF OR VIP CLUB SEATING: Upgrading your package is an additional **\$45.00 per person**. Make request at the time of deposit. This upgrades your Friday and Saturday seats to VIP TURF OR VIP CLUB SEATING.

EXTRA TICKETS: Should you wish to add EXTRA TICKETS to your hotel package for Friday/Saturday, or if you are buying TICKETS ONLY (no hotel) this can be done at the time of deposit. The Extra Tickets will be covered by your \$100 per person deposit to hold your package. However, Tickets Only (no hotel), must be paid in full at the time of booking and are NON-REFUNDABLE. Rates are **\$130.00** per set of Fri/Sat ticket or **\$65** per ticket for the STADIUM seating and **\$170.00** per set of Fri/Sat ticket or **\$85** per ticket for VIP FIELD or CLUB seating.

COACH: Optional \$119 per person additional. Should the minimum of 30 passengers not be met, the \$135 will be refunded.
